Whereas due to less rainfall in the State, the severe drought has been declared in 112 talukas and medium drought is declared in 39 talukas of the State:

And Whereas the live storages in Marathwada, Nagpur and Amravati regions as on October 15, 2018 were 25.53%, 43.38% and 57.62%, respectively;

And Whereas, as per the provisions in section 14(1) of the Maharashtra Water Resources Regulatory Authority Act, 2005 ("Act" for short), from the date of commencement of the Act, no person can use any water from any water source without obtaining the Entitlements from the respective River Basin Agencies;

And Whereas the section 11(s) of the Act, mandates this Authority the function of developing State Water Entitlement database;

And Whereas this Authority is of the opinion that all such entitlement database should be in the public domain;

Now therefore, having considered the gravity of issue and relevant provisions of the Act, this Authority directs the State Government and the River Basin Agencies to furnish the authorized entitlement database to this Authority regarding lifting permissions given from the State sector reservoirs, canals and the notified rivers stretches in the State on their website within 30 days from the date of issue of these directives and also simultaneously publish the same, update the same regularly and also prohibit unauthorized lifting of water from such reservoirs with immediate effect.
