## AUTHORITY MEMORANDUM

1.00 Section 11 (f) of the MWRRA Act (Act No.XVIII of 2005) reads as below:

“To review and clear water resources projects proposed at the sub-basin and river basin level to ensure that a proposal is in conformity with Integrated State Water Plan and also with regard to the economic, hydrologic and environmental viability and where relevant, on the State's obligations under Tribunals, Agreements, or Decrees involving interstate Entitlements:

Provided that, while clearing the new water resources projects by the concerned for construction proposed by River Basin Agencies, the Authority shall ensure that Governor's Directives issued from time to time, relating to investment priority for removal of regional imbalance are strictly observed;


Provided further that, in respect of the projects situated in Marathwada and Vidarbha Regions, the powers to accord administrative approval or revised administrative approval, under this clause, shall in accordance with the Governor's directives, be exercised by the concerned River Basin Agency"

- 2.00 3 - Minor Irrigation Schemes viz at Sr. No. (a) to (c) in Upper Godavari sub-basin of Godavari basin in Nashik Division were received for clearance by MWRRRA under above mentioned Section of the Act, vide above Reference.
- (a) Joran M.I. Tank, Taluka Dindori, District Nashik
  - (b) Ambad M.I. Tank, Taluka Dindori, District Nashik
  - (c) Vani (Kh) M.I. Tank, Taluka Dindori, District Nashik
- 3.00 (i) For projects at Sr. No. (a) & (c), the water availability certificate is given by C.E. (H.P.) Nashik. These projects are in catchment of Completed Karanjvan Major Project. Vide Govt. of Maharashtra letter dated 26/04/2001, 22 diversion schemes were proposed to divert water from west flowing rivers basin to Godavari basin & similar decision was taken in the meeting of the Hon. Minister (WR) dated 13/03/2006. C.E. (H.P.) Nashik vide letter dated 10/05/2006 has certified 19 diversion schemes for 65.74 Mm<sup>3</sup> of water from west flowing rivers basin to Godavari basin. Out of 65.74 Mm<sup>3</sup> water, C.E. (H.P.) Nashik has certified water availability for two projects of 1.10 Mm<sup>3</sup>. Thus net water available for future project is 64.64 Mm<sup>3</sup>. The total utilisation by these 3 - M.I. schemes is 9.30 Mm<sup>3</sup>.
- (ii) The BC ratio is more than 1 for Projects at Sr. No. (a) & (c).
  - (iii) These Projects are within prescribed cost norms in terms of Rs / 1000 cu.m. of Gross Storage.
  - (iv) These Projects are in Nashik District, which is not a back log district and the irrigation potential created as on June 1994 is 33.55 % w.r.t. it's net sown area & as on June 2007 is 44.12 % w.r.t. it's net sown area which is more than the state average of 1994 i.e. 35.11 %. These Projects have a total potential in SRE of 1,760 ha.
- 4.00 Tribal Department, Govt. of Maharashtra, vide their letter dated 07/01/2009 stated that 100% funds will be provided to these 3 projects from tribal sub-plan if these projects get Administrative approval.

Also Secretary to the Governor vide his letter dated 20/01/2009 at Ref No. 3 approved subject to that these 3 projects in Taluka Dindori, District Nashik should be funded only under tribal sub-plan.

- 5.00 Environmental clearance is required for these projects as per Notification of Ministry of Environment & Forests, Government of India, September 2006. The environmental angle clearance may be obtained from State Level Committee as per the stipulation in the MoEF's Notification as above.
- 6.00 It is presumed that these 3 projects do not involve diversion of forest land. A certificate to this effect needs to be furnished from the concerned Forest Dept.
- 7.00 The MWRRA is, therefore, pleased to accord clearance to these projects under Sec.11 (f) of the MWRRA Act as per salient features appended herewith subject to condition that these 3 projects in Taluka Dindori, District Nashik should be fully funded under tribal sub-plan only, environment clearance and certificate required for forest clearance.
- 8.00 This clearance is issued under reference No. 63 dated 30/01/2009 and is registered under No. MWRRA / 2008 / PRCL / GMIDC / NSK-3MI / 1904 dated 30/01/2009 in the office of the Authority.
- 9.00 The Receipt of this Memorandum may please be acknowledged.
