- 1.00 The Project Patkhal (MI) Storage Tank, Taluka Mangalwedha, District Solapur in Rest of Bhima sub-basin of Krishna basin was received for clearance by MWRRA under Section 11 (f) of the Act, vide Ref - 1.
- 2.00 There is no financial backlog in Solapur District as on 01/04/2009. The percentage of irrigation potential created till June 1994 in Solapur District was 45.17 % with respect to its net sown area which was more than State average of 35.11 %. Hence there is no need to take up new irrigation projects in Solapur District as irrigation backlog is already removed by June 1994.
- 3.00 The project presently meets the required techno-economic norms relating to hydrology, B/C ratio and within Cost per TCM norms for M.I. Tank.

4.00 As per Para - 30 and 40 of Hon. Governor's directives for the annual plan 2009 - 10, the Authority has to clear the projects in the backlog districts only & Solapur district is not a backlog district. Therefore this project is returned herewith.


5.00 Districtwise backlog may come up for review in April 2010. On completion of this review, the need for this project established, the project may be resubmitted to MWRRA with revised techno-economic viability with reference to updated cost for according clearance under Section 11 (f) of the MWRRA Act, 2005 before implementation of this project.
