- 1.0 The Project at Sr. No. (a) to (d) in Beed District in Sindfana (Lower Godavari) sub basin of Godavari basin was received for clearance by MWRRA under Section 11 (f) of the Act, vide above References.
 - a) Kapildharwadi (MI) Storage Tank, Taluka Beed, District Beed
 - b) Waghachawada (MI) Storage Tank, Taluka Patoda, District Beed
 - c) Ukhalwadi (MI) Storage Tank, Taluka Shirur, District Beed
 - d) Zapewadi (MI) Storage Tank, Taluka Shirur, District Beed
- 2.00 There is no financial backlog in Beed district as on 01/04/2009. The percentage of irrigation potential created till June 1994 was 28.94% with respect to net sown area & till June 2008; it was 45. .6 % which is more than 35.11% State average of June 1994. Thus Beed district has no physical irrigation backlog of 1994.

- 3.00 The project presently meets the required techno-economic norms relating to hydrology, B/C ratio & and are within cost per TCM of gross storage.
- 4.00 As per Para 30 and 40 of Hon. Governor's directives for the annual plan 2009 10, the Authority has to clear the projects in the backlog districts only & Beed district is not a backlog district. Therefore these projects are returned herewith.
- 5.00 Districtwise backlog may come up for review in April 2010. On completion of this review, the need for these projects established, the projects may be resubmitted to MWRRA with revised technoeconomic viability with reference to updated cost for according clearance under Section 11 (f) of the MWRRA Act, 2005 before implementation of these projects.
