1.00 The Projects at Sr. No. (a) to (e) in Upper Godavari sub basin of Godavari Basin was received for clearance by MWRRA under Section 11 (f) of the Act, vide above Reference.

- (a) Girjadevi (MI) Storage Tank, Tal. Khultabad, Dist. Aurangabad
- (b) Gajgaon (MI) Storage Tank, Tal. Gangapur, Dist. Aurangabad
- (c) Dhupkheda (MI) Storage Tank, Tal. Paithan, Dist. Aurangabad
- (d) Yelganga [Nandalgaon] (MI) Storage Tank, Tal. Paithan, Dist. Aurangabad
- (e) Karkingaon (MI) Storage Tank, Tal. Paithan, Dist. Aurangabad

2.00 These projects presently meet the required techno-economic norms relating to hydrology, B/C ratio & and are within cost per TCM of gross storage.

- 3.00 As per Hon. Governor's directives for FY 2010-11, there is no irrigation backlog in Aurangabad District. Hence there is no need to take up new irrigation projects in this District, as irrigation backlog is removed.
- 4.00 As per Para - 22 and 28 of Hon. Governor's directives for the FY 2010-11, statutory clearance for keeping on shelf can be accorded to the project in Vidarbha region in Godavari basin. Since these projects are in Marathawada region in Godavari basin, these projects are therefore returned herewith.
- 5.00 District-wise backlog is due for review in 2010. On completion of this review, if the need for these projects is established, these projects may be resubmitted to MWRRA with revised techno-economic viability with reference to updated cost for according clearance under Section 11 (f) of the MWRRA Act, 2005 before implementation of these projects.
