Vide Ref No. - 1 Thadi-Pavani (Medium) Lift Irrigation Scheme (LIS),
Taluka Narkhed, District Nagpur was submitted to the Authority for
clearance under Sec. 11 (f) of the Act.

It is proposed to lift water for this LIS from the submergence of Upper
Wardha Project, which will affect the dependability of the Upper Wardha
Project. In this context, water availability certificate along with the design
note from C.E. (HP) Nashik was not enclosed with the project report, which
is essential for processing the project for approval as per the Sec. 11 (f) of the
Act.

Vide Ref No. 2 & 3, the same was conveyed through the Authority's number of letters to your office & the said information is still awaited from your office for more than 2 - years. The project is therefore returned herewith.

However as per Hon. Governor's directives issued from time to time, Nagpur district is not a backlog district with reference to physical as well as financial backlog. Thus the project, even if resubmitted with required compliance & revised techno-economic viability with reference to updated cost, can be given only no objection for processing for environmental & forest clearance and keeping on shelf as per Para - 22 & 28 of the Hon. Governor's directives for annual plan 2010 - 11 and not for the construction purpose.
