**Sub : Returning of Dislyachiwadi (MI) Storage Tank in
Beed District under GMIDC, Aurangabad.**

- 1.00 The Dislyachiwadi (MI) Storage Tank, Taluka Shirur, District Beed, Project in Upper Godavari sub basin of Godavari Basin in Marathwada region was received for clearance by MWRRA under Section 11 (f) of the Act, vide above Reference.
- 2.00 Although this project presently satisfies the criteria of water availability and the B/C ratio is more than one but the cost per TCM of gross storage is not within the prescribed norm for Storage Tank in DPAP area and non-backlog area.
- 3.00 Further vide Hon. Governor's directives for FY 2010-11, there is no irrigation backlog in Beed District. Hence there is no need to take up new irrigation projects in this District, as irrigation backlog is removed.

- 4.00 As per Para - 22 and 28 of Hon. Governor's directives for the FY 2010-11, statutory clearance for keeping on shelf can be accorded to the project in Vidarbha region in Godavari basin.
- 5.00 In view of Para 3 & 4 above, this project is therefore returned herewith.
- 6.00 District-wise backlog is due for review. On completion of this review, if the need for new irrigation project in this district is established, this project may be resubmitted to MWRRA with revised techno-economic viability with reference to updated cost for according clearance under Section 11 (f) of the MWRRA Act, 2005 before implementation of this project.
