**Sub : Returning of Wairagad (MI) Storage Tank in
Buldhana District under VIDC, Nagpur.**

- 1.00 The Wairagad (MI) Storage Tank, Taluka Chikhali, District Buldhana, Project in Purna sub basin of Tapi Basin in Marathwada region was received for clearance by MWRRA under Section 11 (f) of the Act, vide above reference.
- 2.00 This project presently satisfies the criteria of water availability, the B/C ratio is more than one and the cost per TCM of gross storage is within the prescribed norm for Storage Tank under VIDC, Nagpur.
- 3.00 As per Hon. Governor's directives for FY 2011-12 and FY 2010-11, there is no financial backlog but there is physical backlog in Buldhana District. However there are enough ongoing projects to take care of remaining physical backlog vide Para 12 of Hon. Governor's

directives for FY 2010-11, thus there is no need to take up new irrigation projects in this District.

- 4.00 As per Para - 22 and 28 of Hon. Governor's directives for the FY 2010-11, statutory clearance for keeping on shelf can be accorded to the scheme in Vidarbha region in Godavari basin only. These directives are reiterated in Para - 14 of the Hon. Governor's directives for the FY 2011-12. As this scheme is in Tapi basin, the necessity for keeping on shelf does not arise.
- 5.00 In view of Para 3 to 4 above, this proposal is therefore returned herewith.
- 7.00 District-wise backlog is due for review. On completion of this review, if the need for new irrigation project in this district is established, this project may be resubmitted to MWRRA with revised techno-economic viability with reference to updated cost for according clearance under Section 11 (f) of the MWRRA Act, 2005 before implementation of this project.
