AUTHORITY MEMORANDUM

1.00 Section 11 (f) of the MWRRA Act (Act No.XVIII of 2005) reads as below:

"To review and clear water resources projects proposed at the sub-basin and river basin level to ensure that a proposal is in conformity with Integrated State Water Plan and also with regard to the economic, hydrologic and environmental viability and where relevant, on the State's obligations under Tribunals, Agreements, or Decrees involving interstate Entitlements:

Provided that, while clearing the new water resources projects by the concerned for construction proposed by River Basin Agencies, the Authority shall ensure that Governor's Directives issued from time to time, relating to investment priority for removal of regional imbalance are strictly observed;

Provided further that, in respect of the projects situated in Marathwada and Vidarbha Regions, the powers to accord administrative approval or revised administrative approval, under this clause, shall in accordance with the Governor's directives, be exercised by the concerned River Basin Agency".

- 2.00 3 irrigation projects, Sr. No. (a) to (c) in Godavari basin in backlog districts were received for clearance by MWRRA under above mentioned Section of the Act, vide Reference (1) to (3) above.
 - (a) Junasurla L.I.S., Taluka Mul, District Chandrapur
 - (b) Borghat 2 L.I.S., Taluka Mul, District Chandrapur
 - (c) Timtala Storage Tank, Taluka Nandgaon (Kh), District Amravati
- 3.00 (i) Projects at Sr. No. (a) to (c) have been cleared by CE, Hydrology Project, Nasik, for water availability.
 - (ii) The BC ratio is more than 1.5 for 2 L.I.S. and more than 1 for 1 Storage Tank but not considered as project is in backlog area.
 - (iii) 2 L.I.S. in Chandrapur Dist. have a total potential of 12,927 ha. in SRE against total backlog of 13,890 ha in SRE of Chandrapur Dist. as in June 2006. 1 Storage Tank in Amravati Dist. has a total potential of 713 ha. in SRE against total backlog of 1,07,740 ha in SRE of Amravati Dist. as in June 2006.
- 4.00 As per G.R. No. LIS-2007/ (197/07) / WRI dated 15th June 2007, Maharashtra State Electricity Distribution Co. Ltd. has given N.O.C. to give power supply to these 2 L.I.S. in Chandrapur District
- 5.00 Environmental clearance is required for these projects as per Notification of Ministry of Environment & Forests, Government of India, September 2006 and may be obtained from State Level Committee as per the stipulation in the MoEF's Notification as above.
- 6.00 Timtala Storage Tank project involve diversion of 30.53 ha forest land. Approval of the Ministry of Environment and Forest may be obtained for diversion of this forest land and no work should be initiated on this project without this approval. For the other two projects, certificate for non-involvement of forest land may be furnished.
- 7.00 The MWRRA is, therefore, pleased to accord clearance to the above 3 projects under Section 11 (f) of the MWRRA Act as per salient features appended herewith.

- 8.00 This clearance is issued under reference No 12 dated 16/11/2007 and is registered under No. MWRRA / 2007 / PRCL / VIDC / 2L1M / 953 dated 16/11/2007 in the office of the Authority.
