AUTHORITY MEMORANDUM

1.00 Section 11 (f) of the MWRRA Act (Act No.XVIII of 2005) reads as below:

"To review and clear water resources projects proposed at the sub-basin and river basin level to ensure that a proposal is in conformity with Integrated State Water Plan and also with regard to the economic, hydrologic and environmental viability and where relevant, on the State's obligations under Tribunals, Agreements, or Decrees involving interstate Entitlements:

Provided that, while clearing the new water resources projects by the concerned for construction proposed by River Basin Agencies, the Authority shall ensure that Governor's Directives issued from time to time, relating to investment priority for removal of regional imbalance are strictly observed;

Provided further that, in respect of the projects situated in Marathwada and Vidarbha Regions, the powers to accord administrative approval or revised administrative approval, under this clause, shall in accordance with the Governor's directives, be exercised by the concerned River Basin Agency".


- 2.00 Biladi Large M. I. Tank, Taluka and District Nandurbar in Tapi basin in Nashik Division was received for clearance by MWRRRA under above mentioned Section of the Act, vide above Reference.
- 3.00 (i) Project has been cleared by C.E. (H.P.) Nashik for water availability against allocation 21.379 Mm³ made in Master Plan of Tapi basin for Gomai Medium Project, Taluka Shahada, District Nandurbar in Middle Tapi Basin. The Gomai Medium Project has now been deleted by the Water Resources Department. The Central Water Commission had also earlier cleared the Gomai Medium Project for 29.16 Mm³. Thus the water allotted to Gomai Medium Project is now available for other projects in Middle Tapi Basin.
- (ii) The BC ratio is more than 1 and project is in backlog area.
- (iii) This Project is within prescribed cost norms in terms of Rs / 1000 cu.m. of Gross Storage.
- (iv) The percentage of irrigation potential created till June 1994; in Dhule District (including Nandurbar District) was 24.57 % with respect to net sown area which is less than State average of 35.11 % & till June 2007; it was 43.29 % in Dhule district & 33.28 % in Nandurbar District. Thus the physical irrigation backlog of 1994 was removed in Dhule district but Nandurbar District is still in backlog as its percentage of irrigation potential created is less than the State average of 35.11 %. This project has a total potential in SRE of 1,203 ha.
- 4.00 The work of Central Spillway in river gorge portion should only be started after completion of R & R works.
- 5.00 As this project is located in tribal area, the project may be executed from the funds available with Tribal Development Department.

6.00 Environmental clearance is required for this project as per Notification of Ministry of Environment & Forests, Government of India, September 2006 even this project is categorised under minor irrigation project. The environmental angle clearance may be obtained from State Level Committee as per the stipulation in the MoEF's Notification as above. It is presumed that this project does not involve diversion of forest land. A certificate to this effect needs to be furnished from concerned Forest Dept.


7.00 The MWRRA is, therefore, pleased to accord clearance to this project under Sec.11 (f) of the MWRRA Act and Hon. Governor's approval for clearing projects in Nandurbar District vide Ref No. 3, as per salient features appended herewith.

8.00 This clearance is issued under reference No. 40 dated 15/10/2008 and is registered under No. MWRRA / 2008 / PRCL / TIDC / Biladi / 1650 dated 15/10/2008 in the office of the Authority.
