We had fixed the hearing of the Case No 12 of 2015 on the 20 November 2015, however the hearing was preponed to 18 November 2015.

Advocate Mahadev Choudhari, representing the petitioner in Case No. 6 of 2015, brought to our notice the Order dated 27 October, 2015 passed by the Hon'ble High Court of Judicature at Bombay, in PIL No. 144 of 2015. In that, our order dated 26 October, 2015 has been taken on record and copy





made available to the petitioner for filing his reply. He therefore, said that since that Order has been acted upon, the Authority could not hear the review petition.

In view of the fact that PIL No. 144 of 2015 and other related matters pertaining to the Authority's Order dated 26 October 2015 filed before the Hon'ble High Court are already subjudice before the Hon'ble High Court, after careful consideration, we have decided not to hear the review applications in order to preserve judicial discipline and judicial propriety.

With these observations, the review applications stand disposed of.
