Smt. Aparna Dhanmeher has represented and brought to the notice the anomaly of payment she is getting. Her representation along with note and a fact was kept before the Authority. On scrutiny it was brought to the notice of the Authority that those employees who have joined after 1st January 2020 are getting 17% D.A. and those employees whose upward revision is done are also getting 17%. However, only seven employees of the Authority are getting 9% D.A. The details of the employees are attached as **Annexure** –**A**.
