## PUBLIC NOTICE

Maharashtra Water Resources Regulatory Authority (MWRRA) under the provisions of Section 11 (d) and 11 (u) of Maharashtra Water Resources Regulatory Authority Act, 2005 (hereinafter referred to as "the Act") has started the work of review and revision of Criteria for Bulk Water Tariff and Bulk Water Tariff for the control period 1<sup>st</sup> July, 2020 to 30<sup>th</sup> June, 2023 and Authority has approved revised draft Criteria for Bulk Water Tariff in view of comments/suggestions received from the Members of the Focus Groups and draft Bulk Water Tariff Proposal.

Bulk Water Tariff is to be fixed after ascertaining the views of beneficiary public as provided in Section 11 (d) of the Act.
